<u>Legal Title</u> Breast Cancer Control Account, Breast Cancer Fund

<u>Purpose</u> The funds in this account are to be used for early breast cancer detection services for uninsured and underinsured women. These services shall include the following: screenings, medical referrals if necessary, assistance in obtaining necessary treatments, and educational activities. Administrative costs not to exceed 10%, breast cancer screening, testing, and treatment assistance of uninsured or underinsured women.		
<u>Administering Agency/Organization Code</u> Department of Health Care Services/Org 4260		
<u>Major Revenue Source</u> Cigarette Taxes pursuant to Revenue and Taxation Code section 30461.6.		
<u>Disposition of Fund (upon abolishment)</u> Pursuant to Government Code section 16346, absent language that identifies a successor fund, any balance remaining in this fund upon abolishment, shall be transferred to the General Fund.		
<u>Appropriation Authority</u> Moneys in this fund are available upon appropriation by the Legislature.		
<u>State Appropriations Limit</u> Always Excluded —The major revenue source is transferred from another fund, which will be counted in an included fund, the Breast Cancer Fund (0004), and should not be double counted.		
<u>Comments/Historical Information</u> Chapter 661, Statutes of 1993 (AB 2055) Section 8, created the Breast Cancer Fund (Fund 0004). Chapter 483, Statutes of 1994 (AB 3391) Section 1, created two accounts within Fund 0004: the Breast Cancer Research Account (Fund 0007) and the Breast Cancer Control Account (Fund 0009). Chapter 241, Statutes of 2006 (SB 162) Section 1, effective July 1, 2007 split the Department of Health Services into two separate entities: Department of Health Care Services (Org 4260) and Department of Public Health (Org 4265).		

Chapter 23, Statutes of 2012 (AB 1467) Section 46, effective July 1, 2012 changed the Administrative Agency from Department of Public Health/Org 4265 to Department of Health Care Services/Org 4260 as they relate to the Breast and Cervical Cancer Screening Program.

September 2013 revision added the parent fund name - Breast Cancer Fund - to the Legal Title.
