<p><u>Legal Title</u> Developmental Disabilities Program Development Fund</p>

<p><u>Purpose</u> For the purpose of planning and developing new and expanded community facilities and programs for the developmentally disabled. The objective is to create a comprehensive network of programs in every area of the state.</p>	
<p><u>Administering Agency/Organization Code</u> Department of Developmental Services/Org 4300</p>	
<p><u>Major Revenue Source</u> Parental fees.</p> <p>Appropriations from the General Fund.</p> <p>Federal funds.</p>	
<p><u>Disposition of Fund (upon abolishment)</u> Pursuant to Government Code 16346, in the absence of language that identifies a successor fund, any balance remaining in this fund upon abolishment, shall be transferred to the General Fund.</p>	
<p><u>Appropriation Authority</u> Section 4677 of the Welfare and Institutions Code states that the fund is hereby appropriated to the department, and subject to any allocations that may be made in the annual Budget Act.</p>	
<p><u>State Appropriations Limit</u> Excluded - Revenues in this fund are not proceeds of taxes, however, when transferred, may become proceeds of taxes. These revenues are used to provide direct services or products to the payers.</p>	
<p><u>Comments/Historical Information</u> Chapter 1252, Statutes of 1977 added this fund.</p> <p>Effective July 1, 1977, all parental fees collected by or for regional centers are to be deposited in the Developmental Disabilities Program Development Fund. The fund may be augmented by General Fund appropriations and federal funds available to the state for program development.</p>	

Chapter 603, Statutes of 1980 appropriates the Developmental Disabilities Program Development Fund until June 30, 1983. Prior to July 1, 1983, the Department of Finance is required to review the utilization and effectiveness of the Developmental Disabilities Program Development Fund and report its findings to the Legislature.

Chapter 327, Statutes of 1982 re-added the Welfare and Institutions Code section 4677, which includes the creation of the fund. The Developmental Disabilities Program Development Fund is also known as the Program Development Fund.

Pursuant to the Welfare and Institutions Code section 4677(d), in no event shall any of these funds revert to the General Fund.
