| <b><u>Comments/Historical Information</u></b><br>Chapter 106, Statutes of 1989, created the Environmental Enhancement and Mitigation Demonstration Program Fund.<br>Chapter 739, Statutes of 1999 (SB117) removed the word Demonstration from the fund title.<br>Chapter 359, Statutes of 2013 (SB 99) changed the annual allocations to the fund from \$10 million to \$7 million.<br>December 2013 revision changed the Administering Agency from the Department of Transportation, California Transportation Commission/Org 2660 to Secretary of the Natural Resources Agency/Org 0540. |                                                                                                                  |                               |
