Section 30124 of the Revenue and Taxation Code provides the following formula for moneys deposited in the fund: <ol style="list-style-type: none"> <li>(1) Twenty percent shall be deposited in the Health Education Account (Fund 231).</li> <li>(2) Thirty-five percent shall be deposited in the Hospital Services Account (Fund 232).</li> <li>(3) Ten percent shall be deposited in the Physician Services Account (Fund 233).</li> <li>(4) Five percent shall be deposited in the Research Account (Fund 234).</li> <li>(5) Five percent shall be deposited in the Public Resources Account (Fund 235).</li> <li>(6) Twenty-five percent shall be deposited in the Unallocated Account (Fund 236).</li> </ol> |  |                                                                                                                  |
