Purpose

To provide funding for the administration and enforcement of osteopathic physicians in accordance with Business and Professions Codes sections 2450 through 2459.7.

The Osteopathic Medical Board of California (Board) was established to protect the public by exercising its licensing, regulatory and disciplinary functions.

Administering Agency/Organization Code

Department of Consumer Affairs - Bureaus, Programs, Divisions/Org 1111

Major Revenue Source

Application and license fees. Also, seventy-five percent of all fines and forfeitures of bail when prosecution for a violation of the provisions of the Medical Practice Act is initiated by the Board pursuant to Business and Professions Codes sections 2458.

Disposition of Fund (upon abolishment)

Pursuant to Government Code section 16346, in absence of language that identifies a successor fund, any balance remaining in this fund upon abolishment shall be transferred to the General Fund.

Appropriation Authority

Pursuant to Business and Professions Code section 2450 and notwithstanding any other law, the powers and duties of the Board shall be subject to review by the appropriate policy committee of the Legislature.

State Appropriations Limit

Excluded- Revenues in this fund are not proceeds of taxes, however, when transferred, may become proceeds of taxes. These revenues are used to regulate the activities engaged in by the payers.

Comments/Historical Information

The Osteopathic Act was enacted by initiative measure (Proposition 20) on the November 7, 1922 ballot, effective December 21, 1922. The Act originally created this fund.

Chapter 615, Statutes of 2001, administering agency change from Osteopathic Medical Board of California to Department of Consumer Affairs.

Chapter 359, Statutes of 1991, renamed from Board of Osteopathic Examiners Contingent Fund to Osteopathic Medical Board of California Contingent Fund.
