<u>Purpose</u> Moneys in the fund are used to regulate and control the practice of speech-language pathology and audiology in accordance with Business and Professions Code sections 2534 through 2534.2.	
<u>Administering Agency/Organization Code</u> Department of Consumer Affairs – Bureaus, Programs, Divisions/Org 1111	
<u>Major Revenue Source</u> License application and renewal fees pursuant to Business and Professions Code sections 2534.2	
<u>Disposition of Fund (upon abolishment)</u> Pursuant to Government Code section 16346, in the absence of language that identifies a successor fund, any balance remaining in this fund upon abolishment, shall be transferred to the General Fund.	
<u>Appropriation Authority</u> Business and Profession Code section 2534 states the fund is created to carry out the provisions of this chapter.	
<u>State Appropriations Limit</u> Excluded – Revenues in this fund are not proceeds of taxes, however, when transferred, may become proceeds of taxes. These revenues are used to regulate the activities engaged in by the payers.	
<u>Comments/Historical Information</u> Chapter 1355, Statutes of 1972, originally created this fund under the title Speech Pathology and Audiology Examining Committee Fund. Chapter 746, Statutes of 1990 re-titled the fund to Speech-Language Pathology and Audiology Examining Committee Fund. Chapter 758, Statutes of 1997, changed the fund title to Speech-Language Pathology and Audiology Board Fund. Chapter 74, Statutes of 2005, repealed continuously appropriated language in the Business and Professions Code section 2534. Chapter 309, Statutes of 2009, re-titled the fund to Speech-Language Pathology and Audiology Fund.	

Chapter 449, Statutes of 2011, re-titled the fund to Speech-Language Pathology and Audiology and Hearing Aid Dispensers Fund.

The Speech Language Pathology and Audiology and Hearing Aid Dispensers Board administer this fund within the Department.

Effective October 2015, administering agency change from the Department of Consumer Affairs – Regulatory Boards/Org 1110 to the current organization.
