<u>Purpose</u>

Chapter 899, Statutes of 2004 established the School Facilities Needs Assessment Grant Program to provide one-time grants for school districts to complete required comprehensive needs assessments of their schoolsites ranked in deciles 1 to 3 on the Academic Performance Index (API) for 2003.

The School Facilities Emergency Repair Account was created to deposit certain specified appropriations to reimburse schools, ranked in deciles 1 to 3 on the API, for unforeseeable emergency facilities, as specified. The following funds made available pursuant to this article shall supplement, not supplant, existing funds available for maintenance of school facilities:

- Commencing with the 2005-06 fiscal year, an amount of money will be transferred in the annual Budget Act from the Proposition 98 Reversion Account to the School Facilities Emergency Repair Account equaling 50% of the unappropriated balance of the Proposition 98 Reversion Account or \$100,000,000, whichever amount is greater.
- The Legislature may transfer to the School Facilities Emergency Repair Account other one-time Proposition 98 funds, except funds specified pursuant to Section 41207.
- Donations made by private entities.

Funds shall be transferred pursuant to this section until a total of \$800,000,000 has been disbursed from the School Facilities Emergency Repair Account.

Disposition of Fund (upon abolishment)

Pursuant to Education Code section 17592.71 (e), any unencumbered balance available in the School Facilities Emergency Repair Account after July 1, 2018, shall revert to the Proposition 98 Reversion Account.

Appropriation Authority

Pursuant to Section 17592.72 (a): "All moneys in the School Facilities Emergency Repair Account are available for reimbursement to schools ranked in deciles 1 to 3, inclusive, on the Academic Performance Index, pursuant to Section 52056, based on the 2003 base Academic Performance Index score for each school, as defined in subdivision (b) of Section 17592.70, to meet the repair costs of the school district projects that meet the criteria specified in subdivisions (c) and (d) and as approved by the State Allocation Board."

State Appropriations Limit

Always Excluded – The major revenue source is transferred from another fund which has already been counted or will be counted in an included or always excluded fund and should not be double counted.

Comments/Historical Information

September 2004: Chapter 899, Statutes of 2004 (SB 6) created this fund.

March 2025: Chapter 15, Statutes of 2017 (AB 99) added Education Code section 17592.71 (e), updated the disposition of the fund. This fund is administratively abolished pursuant to Government Code section 13306 (b).
